**MLA Citation and Works Cited Guide**

- This sample citation guide will show you how to write your MLA citations. Ask us if you have questions or visit [www.mla.org](http://www.mla.org).
- **Double space** entire Works Cited Page.
- **Center** the words "Works Cited" at the top of the page.
- **Put** last name and page number as a header in the upper right hand corner.
- **Alphabetize** entries and indent second and following lines (CALLED A HANGING INDENT).

**BOOK- CORPORATE AUTHOR 5.5.5**

Name of person interviewed (last name first). "Title of Interview" (if no title Interview). *Title of publication*.

### **WEB PUBLICATIONS 5.6**

Use *n.p.* if no publisher name is available and *n.d.* if not publishing date is given.

### **AN ENTIRE WEBSITE**

Editor, author, or compiler name (if available) (last name first). *Name of Site*. Version number. Name of

institution/organization affiliated with the site (sponsor or publisher), date. Medium of publication. Date of access.

### **A PAGE ON A WEBSITE**

Follow same format as above.

### **AN IMAGE (PAINTING, PHOTOGRAPH OR SCULPTURE)**

Artist's name (last name first). *Work of Art*. Date of creation. Institute or city where work is housed. *Name of Website*.

Medium of publication. date of access.

Goya, Francisco. *The Family of Charles IV*. 1800. Museo Nacional del Prado, Madrid. *Museo Nacional del Prado*.

Web. 22 May 2006.

### **ONLINE MAGAZINE**

Author name (last name first). "Title of article." *Title of Magazine*. Publisher name, publisher date. Medium.

Date of access.

### **ONLINE NEWSPAPER**

Author of article (last name first). "Title of Article." *Title of Newspaper* Date published. Web. Date accessed.

### **FORMAT TO FOLLOW FOR ONLINE DATABASES**

"Cite articles from online databases (e.g. LexisNexis, ProQuest, JSTOR, ScienceDirect) and other subscription Service just as you would print sources" then add the database used, medium of publication (web) and date of access (OWL).

### **Internal Documentation**

The MLA method of internal documentation allows the reader of your paper to easily trace the source of your material to your Works Cited Page. You, the writer, **MUST** use **internal documentation** to give credit to *any* ideas not your own and to any quoted words. Internal documentation tells exactly what information you have summarized, paraphrased, or quoted and exactly where you found the material.

### **Internal Documentation Models**

- 1. Book, 1 Author:** More seeing-eye dogs are being trained (Mills 46). (author's last name followed by the page number)
- 2. Book, 2 or 3 Authors:** Math skills among young Americans have improved (Baldwin and Clark 21). (Both authors' last name in the order they are listed followed by the page number)
- 3. Book, more than 3 authors:** Additional world civilization courses are being offered in today's colleges (Lopez et al. 321). (The last name of the first author listed followed by "et al." followed by the page number)
- 4. Article in a reference book:** "Religion is a set of beliefs concerning the cause, nature, and purpose of the universe" (*Merriam-Webster's Collegiate Dictionary* 1145). (Title of the reference book followed by the page number)
- 5. Pamphlet:** Today's students are choosing more science careers (Stewart). (Author's last name)
- 6. Newspaper:** The use of vitamins has increased fifty percent in the past year (Smith A1). (Author's last name followed by the section and page number).

**7. Magazine:** The cure rate for all types of cancer doubled during the past decade (Parker 35). (Author's last name followed by the page number).

**8. Interviews:** I have found volunteering in my child's school very rewarding (McKay). (Last name of person interviewed).

**9. Infotrac:** Kentucky needs more family practice doctors (Martin). (Cite by author's last name. If it's not given, use a shortened version of the title of article).

**10. Encyclopedia Online:** The Atlantic Ocean is cleaner today than a decade ago ("Oceans of the World"). (Cite by author's last name. If it's not given, use a shortened version of the title of article).

**11. SIRS:** Sports cars are safer today than even (Jones). (Cite by author's last name. If it's not given, use a shortened version of the title of article).

**12. General Internet:** "Mr. Showbiz" will soon have a new cast of characters ("Mr. Showbiz"). (Cite by author's last name. If it's not given, use a shortened version of the title of article).

\*\*As a general rule, you always cite by the author's last name. If there is no author given, cite by the next information given in the Works Cited entry (usually the title of the article).

### **Works Cited Page**

The Works Cited page is a list of sources you used in your paper. If a source appears on this page, it should be documented somewhere in your paper as well. It should include all the sources you quoted, paraphrased, or summarized in your paper. If you examined a source but did not cite it, it should not be listed on your works cited. This list should be the last page of your research paper. **Start a new page—no part of your paper should be included here, except for sources used.**

Follow these guidelines for creating your works cited page: Arrange your sources in alphabetical order by last name of the author. If an author is not given in the source, alphabetize the source by the first main word of the title.

Center the Works Cited. Do **NOT** underline.

Double space between the title and the first entry.

Type the entire list **double-spaced** (both **within** and **between** the entries).

Use a **handing indent:** Indent the second and subsequent lines of each entry five spaces from the left.

**Sample:** The works cited page should always be on a page by itself.
